







Social Matrix Exercise




Blank Social Matrix Template

Intersectionality



Intersectionality


Intersectionality promotes an understanding of human beings as shaped by the interaction of different social locations (e.g., 'race'/ethnicity, Indige-neity, gender, class, sexuality, geography, age, disability/ability, migration status, religion).


Tenets of Intersectionality

- Human lives cannot be reduced to single categories;
- When analyzing social problems, the importance of any category or structure cannot be predetermined;
- Relationships and power dynamics between social locations and processes are linked. They can also change over time and be different depending on geographic settings.




Tenets of Intersectionality (cont.)

- ❖ People can experience privilege and oppression simultaneously. This depends on what situation or specific context they are in.
- Intersectionality is explicitly oriented towards transformation, building coalitions among different groups, and working towards social justice.
