Individual Placement and Support Principles

- Competitive employment is the goal
- Eligibility is based on consumer choice zero exclusion
- Consumer preferences are important
- Supported employment is integrated with treatment
- Personalized benefits counseling is provided
- Employment specialists systematically develop relationships with employers based upon their client's work preferences
- Rapid job search -- starts soon after a consumer expresses interest in working
- Follow-along supports

IPS PROS Initiative

2014

- 59 programs participated in 7 regional learning collaboratives
- Employment outcomes were consistent with national benchmarks (i.e., 41% or more of those receiving IPS services working competitively at least one day the previous month)
 - December 2014 data
 - 49.3% employment rate for those receiving IPS services in programs that have worked with CPI for longer than one year
 - 45.6% employment rate for those receiving IPS services in programs that have worked with CPI for one year





IPS PROS Initiative (cont.)

Use of Learning Collaboratives by the Center for Practice Innovations to Bring IPS to Scale in New York State

This column focuses on use of learning collaboratives by the Center for Practice Innovations to help programs implement the evidence-based individual placement and support model of supported employment in New York State. These learning collaboratives use fidelity and performance indicator data to drive the development of program-specific individualized quality improvement plans. As of 2014, 59 (69%) of 86 eligible programs have joined the initiative. Programs are achieving employment outcomes for consumers on par with national benchmarks, along with improved fidelity.

The Center for Practice Innovations (CPI) is funded by the New York State Office of Mental Health (OMH) to bring best practices to mental health programs across the state (1). Large systems face the challenge of helping practitioners in diverse programs adopt evidence-based practices. This challenge includes reaching all programs, regardless of whether they would be naturally inclined to participate. Because of the large number of programs and the large geographic area, New York State (NYS) cannot afford traditional approaches to dissemination, such as use of consultant trainers for individual agency training. for more than a decade (2,4). A study that focused on 127 sites involved in the Johnson & Johnson-Dartmouth Community Mental Health Program found that the mean quarterly employment rate for individuals receiving IPS services over eight years was 41% (5,6). Employment was defined as working in a competitive job for one day or more in the quarter. IPS principles include zero exclusion, integration of employment and mental health services, competitive employment as the goal, and rapid job search. Key services include developing a meaningful employment plan that reflects the consumer's

IPS PROS Initiative: 2015

- 61 programs have joined this initiative for 2015
- Program separated into 2 Learning Collaboratives:
 - 22 self-identified as <u>implementing</u> participating in learning collaboratives and receiving a full package of training and implementation support
 - 39 self-identified as <u>sustaining</u> -- participating in webinars, training, and consultations tailored to their expressed needs





"Implementing" Learning Collaborative

Programs agreed to:

- Attend online and face to face meetings
- Conduct periodic fidelity self-assessments
- Submit monthly performance indicator data
- Develop and use quality improvement plans
- Share experiences with one another



Resources Include

- Three online training modules
 - Introduction to IPS
 - Job Development
 - Employment Resource Book (NEW)
- Statewide webinars and regional online meetings
 - Topics included IPS fidelity, supervision, CQI and use of data, hosting an employment day, billing and documentation, motivating participants for work
- Regional face to face workshops



Resources Include (cont.)

- Program-specific, on-site technical assistance and training
- Program specific, telephone consultation
- Online IPS library
 - Implementation tools, archived webinars, and other resources
- CPI's Employment Resource Book



"Sustaining" Learning Collaborative

Programs agreed to:

- Conduct periodic fidelity self-assessments
- Submit monthly performance indicator data
- Attend optional webinars and monthly conference calls as needed
- Reach out for additional technical assistance as needed (e.g., phone calls, site visits)

*These programs also had access to the same resources just reviewed for implementing programs



2015 PROS Data

Employment outcomes are consistent with national benchmarks (i.e., 41% or more of those receiving IPS services working competitively at least one day the previous month)

September 2015 data

- Programs in "implementing" stage: 32.5% rate of competitive employment the previous month (i.e., worked at least one day that month)
- Programs in "sustaining" stage: 43.7% rate of competitive employment the previous month
