## Wellness

### • Who We Are - MHA in Essex County

- Located Upstate Essex County, NY, includes Lake Placid, N.Y.
- Community Demographics: 37,000 total population, no large cities, only 7 traffic lights in the county, 2% minority, poverty is widespread, major industries are tourism and prisons
- Agency Stats: Census, Staffing, Annual Budget: 25 staff serving about 900 unique individuals per year
- Participants We Serve: Adults only
- Programs & Services: OMH Supported Housing (30 beds), Health Home Case Management (average monthly census 140), mobile crisis services including a direct law enforcement referral program (LEMHRS), 24/7 warmline, psychosocial groups. ACCESS-VR contract, Adult HCBS.
- Our Wellness Vision & Approach: MHA in Essex County seeks to assist adults with behavioral health issues by meeting them where they are in their recovery. We embrace a harm reduction approach.

### • Who We Are - Association for Mental Health and Wellness

- Located Downstate Suffolk County, NY:
  - Very high cost of living; Poverty 6.8%; Homeless 3,843
- Community Demographics:
  - Population: 1.52+ Million; 18.61% Hispanic; 7.17 % Black/AA; 3.99% Asian; 66% White; 2020 Census reported increase in diversity from 2010
- Agency Stats:
  - Annual Budget \$15M; Staffing 187 employees
- Participants We Serve:
  - 1746 active, adults, children, families; BH/SED/CT ; co-occurring substance abuse and medical conditions
- Programs & Services: MHA affiliate/advocacy; (2) PROS, HCBS/CORE, HHCM, Peer Training, Peer Support Services, Recovery Center; Veterans - SSVF, Dwyer Project; Food Pantries; Supportive Housing; Workforce Training & Education; opening Peer Run Crisis Residence 2022
- Our Wellness Vision & Approach: Person-centered, trauma informed, recovery & diversity driven. "Empowering and inspiring people of all communities to identify, pursue and sustain healthy, meaningful lives."

### OUR PANDEMIC YEAR—A COVID-19 TIMELINE

On March 11, the WHO declared COVID-19 a pandemic. Here is a look back at a year in disruption.

#### A MYSTERIOUS NEW ILLNESS

Images appear of Wuhan in lockdown, where officials attempt to contain a mysterious virus. Soon after, new cases of and deaths related to (what's later named) COVID-19 surge in Europe.

#### THE WORLD SHUTS DOWN


Countries seal borders; sports teams cancel seasons: schools close and employees go home. People start wearing masks and "social distancing."

### UPTICK IN MENTAL HEALTH ISSUES

People struggle as continued unemployment and/or working from home without childcare/school takes its toll. U.S. break records for daily cases/deaths.

### LIGHT AT THE END OF THE TUNNEL?

2021 begins with a race to vaccinate. Cases and deaths begin to fall. But the variants are still a threat, vaccine rollout is uneven, and we are still wearing masks.



### THE VIRUS SPREADS. CASES MULTIPLY

The Grand Princess cruise ship, docked outside of San Fran, has passengers with COVID-19; Bay Area is first in the U.S. to announce shelterin-place orders; hospitals become overwhelmed as cases grow; there is a nationwide shortage of PPE.


### FLATTENING THE CURVE-FOR A WHILE

After "flattening the curve," cases begin to skyrocket again as states "reopen" in different phases. Researchers continue to race to identify effectiveness of vaccines. treatments and make vaccines.

# 2021– A Year of Recovery...?

### • MHAW

- Miracle of Miracles Vaccines Arrive
- Project Hope for Covid-19
- PROS Awakenings June in-person hybrid groups
- Pop Up Vaccination Clinics 172 starfish
- MHA in Essex had quickly learned to provide virtual services in 2020 and in 2021 started to return to in person services. By April of 2021 98% of our staff were vaccinated and our staff were back in the community and in homes.

- MHA in Essex County Participant Experience
  - Health Concerns: The existing opioid crisis worsened. In 2020 there were 4 fatal opioid overdoses in Essex County. To date in 2021 the death toll stands at 11. alcohol abuse increased. Domestic violence increased.
  - **Stressors:** financial stressors initially but reduced with stimulus payments
  - Impact on Mental Health & Substance Abuse: Referrals from law enforcement increased almost 300 %. Warmline calls increased 200 %
  - **Tech Disparities:** Many consumers lacked internet access and smartphones. Instituted phone card program so consumers could remain linked with providers.
  - Food Insecurity: Food pantry transition to delivery
  - **Discovering Resilience:** Our consumers with mental health concerns were largely socially isolated to start with. Most adapted to the new COVID environment well.

### Wellness

### MHAW Participant Experience

- Health Concerns: Covid-19 restrictions; access to PPE; maintaining medication access; cancelled medical appointments; increase in medical admissions
- **Stressors:** financial \$\$; parenting & teaching; transportation; layoffs/job loss; social isolation; increased food demands;
- **Impact on Mental Health & Substance Abuse:** Isolation = increase in self-reported depression & anxiety, substance use, tobacco use, over-eating; **Grief**: loss of family, friends, roommates to Covid-19
- **Tech Disparities:** Limited to no internet access in residences; libraries closed, open access WiFi unavailable or poor quality; lack of reliable & affordable smartphones; increased data usage and limited carrier range; leveraging Service Dollars to purchase laptops; grateful for telephonic connections
- Food Insecurity: 600% increase in Food Pantry usage; Grab & Go delivery to participants; creative arts materials included
- Discovering Resilience: naturals supports flourished; meetups via FaceTime; safe gatherings outside; many realized & used the tools learned for self-care & coping -> and moved on.

### Wellness

### • MHA in Essex County - Impact on Staff

- **Personal Life Stressors:** Mad dash to get staff printers/scanners to facilitate work at home. Most staff were responsible and get their work done. We retain a work from home as desired policy. Staff take turns with office coverage.
- Work / Life Balance: Many staff ignored work hours and had to be reminded when the work day ends.
- **Parent & Teacher:** Staff with children in school were given flexible work hours.

### • Lack of In Person Contact

- With clients: Staff lacked the personal connection that comes with ftf
- With colleagues: Staff needed Zoom meetings with supervisors so we can get a read on how they are doing. No hallway conversations and staff comradery.
- **Compassion Fatigue:** The increase in workload and degree of crisis intensity caused supervisor concerns about staff burn-out.

## Wellness

- MHAW- Impact on Staff
  - **Personal Life Stressors:** Covid-19 risks, insomnia, shared space stress, no down time, irritability
  - Work / Life Balance: blurred boundaries, sitting too much
  - **Parent & Teacher:** Juggling WFH and "home-schooling"; women most affected; schedule accommodations needed

### Lack of In Person Contact

- With clients: missing personal connection, F:F contact; concern their for health and risks
- With colleagues: virtual meetings a god-send, but missed each other; disconnection from routine, structure; time-management issues developed, performance concerns
- **Compassion Fatigue:** Covid risk is everywhere; masks love them/hate them! No time to do (blank)...

## Wellness

### • What We Did - MHA in Essex County

- We invited all consumers to a virtual forum each Wednesday, plus an Open Mic Thursday evenings and TGIF Friday mornings
- After virtual monthly staff meetings we provided a one hour coffee hour for informal chit chat among staff
- We had weekly virtual case review with a clinical consultant and made time for individual staff sessions with our clinical consultant
- Director of Services scheduled in person outdoor masked meetings with every staff member individually.
- Required vacation days for staff who had not had a vacation during COVID

## Wellness

### • What We Did - MHAW

  - Outreach Wellness Check-in Calls & Visits
  - Weekly Zoom Community Meetings
  - SMART In-person Services
  - Grab & Go Food Pantry Delivery & Arts Materials, Games
  - Hosted Vaccination Pop-up Clinics
  - Assisting in scheduling vaccination appointments
  - Vaccine Education & Hesitancy Workshops with Medical Experts

### • What We Did – MHAW

- Staff
  - Weekly All Staff Huddles
  - Daily Check-In's with Teams
  - Morning Meditation
  - Comedy Break on Thursdays at Noon
  - Parenting Collective
  - EAP Offerings
  - Wellness Committee Events:
    - So Much Sitting: Back Health Presentation
    - Cigna Emotional Well Being Seminar
    - Mindfulness-based Stress Reduction Presentation (Northwell Cardiologist)

- Where We Are Today MHA in Essex County
- The Delta variant is worsening but we will maintain ftf services
- We continue a work from home policy with shared office coverage.
- We have increased ability to outreach law enforcement referrals in person
- We are transporting consumers for vaccination and boosters
- We are working with OASAS partners to get Narcan kits out in the community.


